### Participation Terms & Conditions

These terms & conditions govern your participation in the Event. By registering for and or participating in the Event, you agree to these terms and conditions.

1. “We”, “us”, “our” or “Quadient” refers to the entity within the Quadient Group hosting the Event. Quadient Group refers to Quadient S.A. and any direct or indirect subsidiary of it.
2. Quadient may hire third parties to organize and run the Event (“**Service Providers**”) with whom you have a separate agreement and Service Providers’ terms and conditions should be read in conjunction with these terms and conditions.
3. You may be contacted by email, phone, SMS and/ or post in relation to the Event ensuring Quadient or its Service Providers can deliver the necessary administrative and event-related communications required to complete your successful participation and fundraising for the Event. Your personal data will be processed in accordance with Quadient’s [privacy policy](#). Quadient will share your contact details with the Service Providers, and where necessary, with other third parties involved in the administration of the Event.
4. Any photography or film footage taken as part of your participation in the Event can be used for promotional and marketing purposes related to this Event and any future

5. You need to be satisfied that you are physically capable of participating in the Event without undue risk to your health or life. We do not conduct health or fitness checks on participants and the responsibility for your ability to participate in the Event is with you as the participant. If you have a medical condition or are unsure of your physical ability to take part in the Event, you must seek medical advice from a general practitioner prior to participating in the Event.

You must follow any rules (including without limitation rules related to health & safety) communicated to you by Quadient and / or the Service Providers related to your participation in the Event and at all times behave in a professional, respectful and courteous manner. You should not engage in any behavior which can bring Quadient and/or its Service Providers into disrepute.
7. All participants attend the Event entirely at their own risk. We shall not be liable for any injury or loss to persons or their property that might occur as a result of your or their participation in or attendance at the Event, other than in respect of any injury or loss arising as a result of our negligence. For the avoidance of doubt, nothing in this clause shall exclude or limit our liability for any liability that cannot be excluded or limited by law.

Quadient and/ or its Service Providers reserve the right to remove your participation from the Event where in Quadient's sole discretion it is determined that your continued participation (i) may be a risk to yourself or to others; (ii) you refuse to follow the participation rules; (iii) you breach these terms and conditions; (iv) in the event of any harmful or reckless acts from you; (v) or in the event of your conduct is deemed unacceptable.
